Hello Agent Pipeline,

Below you will find the Links and Package Codes to begin agency and agent certifications for the upcoming selling year. You will find 3 links and package codes below. One will be for downline agencies, one for Captive agents (*Selling Principals and any agent who is to be paid by their Upline Agency; Gateway to pay agent commissions directly to certified agency*), and one for Non-Captive agents (*Any agent who is to be paid directly by Gateway Health*). **Gateway Health will send these links to each of the downline agencies currently active within your downline** (see spreadsheet attachment for full list). You will need to submit the appropriate link to any agencies and agents you wish to have certified with Gateway Health that are not found on this list. Once each downline agency has submitted their application and been certified, Gateway Health will then send the Captive Agent and Non Captive Agent links to the certified agency. Agencies will not receive downline agent links until they have submitted their application for review.
