Begin in the **Prerequisites Required** learning path and follow the three steps shown here:



- Start your process with the new Overview course. This
 is where you will find basic instructions, a detailed user
 guide, the reference guide, and highlights of what's new
 for 2022.
- Sign the Pledge of Compliance and attest to any conflicts of interest.
- 3. Decide which course program you are going to follow:
 - UnitedHealthcare
 - · AHIP
 - Servicing program.

You only need to complete one program, not all three.

As in past years, Medicare Basics includes MA, PDP, and AARP® Medicare Supplement!

 When you pass Medicare Basics or transfer your passing AHIP score, you will be given conditional credit for Medicare Advantage, Prescription Drug Plans (PDP), and Medicare Supplement products. Once you pass the remaining two prerequisite assessments (Ethics

- and Compliance and the AARP® 101 Module), you will be certified to sell non-Special Needs Medicare Advantage plans, stand-alone PDPs, and AARP® Medicare Supplement Insurance plans.
- To sell Chronic or Dual Special Needs Plans (DSNP), take the Chronic/Dual SNP module and test after you have passed all your prerequisite tests. (Product and Events Learning Path)
- Don't forget to take 2022 Events Basics if you plan to conduct inperson or virtual events! (Product and Events Learning Path)

How to take certifications

- Certification modules and tests are open 24 hours a day, seven days a week on *Jarvis*>Knowledge Center>Learning Lab.
- You will have six attempts to complete an assessment with a minimum passing score of 85 percent.
- When you launch an assessment, an attempt is counted when you complete the assessment.
- Answer a question correctly and you'll move immediately to the next question; answer a question incorrectly and you'll receive feedback that it was wrong and then you will move to the next question.
