## Medico 2022 Agent Incentive Program details and rules:

- Qualifying policies include Medicare Supplement insurance plans from Medico Insurance Company or Medico Corp Life Insurance Company written in the following states starting January 1, 2022: AZ, CO, GA, IA, IN, KS, KY, LA, MI, MO, MS, NC, NE, OH, PA, SC, TN, TX, and WI.
- Applications must be dated between Jan. 1, 2022, and Mar. 31, 2022, for AZ, CO, GA, IA, IN, KS, KY, LA, MI, MO, MS, NC, NE, OH, PA, SC, TN, TX, and WI. Effective dates for all must be no later than May 1, 2022.
- After a minimum of three approved and taken Medicare Supplement applications, agents will receive:
  - a. \$100 for each underwritten application.
  - b. \$25 for each guaranteed issue application.
  - c. \$25 for each open enrollment application.
- 4. Payout will occur approximately 45 days after qualifying.
- Policies must be approved before the payout to be eligible.
